Whether they can build on this and move toward a more permanent peace remains an open question, but at least for the moment the shifting geopolitical winds are providing a seemingly rare opportunity to talk instead of fight.

"It eases the pressure," Najmuddin Shaikh, Pakistan's former foreign secretary and ambassador to nations including the US, said by phone when asked about the ceasefire. "Essentiallywhat needs to come ahead is what has been proposed - that there be a resumption of dialogue."

# बायोटेक' से दो करोड़ खुराक खरीदेगा

साओ पाउलो, २६ फरवरी (एपी)।

ब्राजील के स्वास्थ्य मंत्रालय ने कोविड-19 के टीके 'कोवैक्सीन' की दो करोड़ खुराक खरीदने के लिए भारत की दवा कंपनी 'भारत बायोटेक' के साथ समझौता किया 'कोवैक्सीन' के इस्तेमाल को हालांकि स्थानीय नियामकों ने अभी तक मंजूरी नहीं दी है। यह समझौता उस दिन किया गया, जब ब्राजील में संक्रमण से मौत का आंकड़ा ढाई लाख पर पहुंच गया है।

ब्राजील के राष्ट्रपति चेयर बोलसोनारो के प्रशासन ने बताया कि 'कोवैक्सीन' टीके की 80 लाख खुराक की पहली खेप मार्च में आएगी। 80 लाख खुराक की दूसरी खेप के अप्रैल में और अन्य 40 लाख खुराक के मई में आने की संभावना है। ब्राजील टीकों की कमी के कारण अपनी 21 करोड़ की आबादी में से केवल चार प्रतिशत लोगों को ही टीके लगा पाया है। देश की दवा कंपनी 'प्रीसीसा मेडिकामेंटोस' और 'भारत बायोटेक' दोनों में से किसी ने इस समझौते की अभी पृष्टि नहीं की है।
